

Privacy Policy

III. Use of cookies:

Cookies are small text files that, like most other Web servers, we place in your device that you use to access our website. This is done to recognize your device during a session or in your future visits to our website, primarily in order to provide better user experience.

Types of cookies used:

Session cookies also assist the user in navigating the website, and allow the user to access secure parts of the webpage when logged in.

Persistent cookie: Persistent cookies are stored on a user's device even after termination of a browsing session. It helps in recalling the preferences or actions of the user. Persistent cookies are used for a variety of purposes such as retaining the visitor's language and regional preference(s) at the end of each browsing session.

We do not collect any personal identifiable information like name, contact details, Email addresses etc. on our website.

We will use cookies to identify how you arrived at our website, to sample what pages you found more interesting or relevant, navigational experience and patterns around our website to make it more effective and to derive choices on how to make it relevant for users.

Depending on the type and settings of your browser, cookies may be accepted by default. Most Browsers accept cookies by default. You may change the settings of your browser to delete existing cookies or prevent future cookies from being automatically accepted. If you disable cookies, certain parts and functions of our website may not be available.
